- f. Replacement battery shall be the same TBP model number or another TBP battery model of greater value with the same aircraft approval solely at TBP's discretion.
- g. This warranty is limited to batteries which have been inspected and maintained in accordance with TBP's applicable Component Maintenance Manual (CMM) and for which proof of same can be established via the maintenance log attached and/or logbook entries or other information deemed sufficient solely at the discretion of TBP. This includes periods of operation and non-operation. Batteries which have been abused or neglected are not under warranty.
- h. Only Teledyne manufactured electrolyte may be used in the battery.
- The battery installed must be approved for the aircraft into which it is installed.
- j. TBP reserves the right to change any battery specifications or prices without incurring any responsibility with regard to batteries previously sold.
- k. Warranty is not transferrable between aircraft or owners.

CHARGING BASICS

Review and follow the latest applicable CMM @ Gillbatteries.com. The following are helpful guidelines only.

Correct charging is very important and will affect the overall life of the battery. The charging process is not 100% efficient and will typically be 10% to 20% higher than the amount of capacity removed during discharge.

Undercharging a battery occurs when the required 110% to 120% of the removed capacity is not returned during recharge. Undercharging will cause a lead sulfate increase in the plates, causing a permanent loss of capacity.

Overcharging a battery repeatedly will corrode the grids in the positive plates and break down the water in the electrolyte to hydrogen and oxygen (electrolysis) and lead to failure.

Charging efficiency is affected by temperature. Lower temperatures will require higher charging voltages and vice versa for higher temperatures.

Constant Current (CC)

Useful in recovering deeply discharged batteries, if performed per GILL instructions. This method uses a constant current throughout the charging period. Voltage could be as high as 2.67 volts per cell.

You MUST have a functional timer to end charging! Since the charge rate is constant, prolonged charging using this technique will result in excessive water loss and accelerate battery failure

Constant Voltage (CV)

Charger output voltage is constant – typically around 2.36 volts per cell.

Initial charge rate is dependent on the charger – could be as high as 10A. The rate will continue to drop as the battery voltage approaches the charger output voltage (battery internal resistance changes)

End of charge is typically determined by the drop in charging rate to less than 0.5 amps.

Trickle chargers are also constant voltage chargers.

CONTINUED AIRWORTHINESS TESTING

If you cannot discharge a battery at the recommended discharge rate, call Teledyne Tech Support for the performance curve for that battery. This curve can be used to determine the discharge time for a known discharge rate to a specified end voltage (1.67 volts per cell).

MANAGING PERIODS OF NON-USE/LIMITED USE

Teledyne recommends that the battery be removed from the aircraft during extended periods (more than 30 days) of non-use or between repeated short duration flights (typically less than one hour, once or twice a month) and kept on trickle charge or fully recharged prior to the next flight.

BATTERY SAFETY

- Call technical support to begin the warranty process within 7 days of failure and have the serial number and maintenance information handy. Do not dispose of battery until Tech. Support evaluation is completed.
- Validated warranty claims will either be shipped a replacement battery from Teledyne or will be given a Warranty Authorization number to use on this form (see step 5).
- 5. Complete this form both sides including the provided Authorization #. Remove Serial Number sticker from old battery and affix to form in box above the Maintenance Log. Return to any authorized Dealer/ Distributor within 30 days of GILL authorization for a replacement GILL battery. GILL authorization remains in effect for 90 days from issuance, void thereafter. Add the New (replacement) GILL Serial Number to this form. Submit original form to Dealer/Distributor at time of exchange.
